



ANNUAL (12 MONTH) COMPANY MEMBERSHIP FEES FROM 1 OCTOBER 2026

ADHESIVE AND SEALANTS MANUFACTURERS, SUPPLIERS OR DISTRIBUTORS (BANDS A-H)

Subscriptions are based upon total relevant annual sales of just adhesives and sealants sales in the UK and Ireland to include all products manufactured in the UK and Ireland for domestic or export consumption plus products imported for sale in the UK and Ireland. Rates are on a sliding scale and are calculated as a percentage of the relevant turnover in GBP up to a capped rate of £16,480 on a member's self-declaration. Any change in the basis or membership is subject to a six-month notice period.

RAW MATERIAL SUPPLIER MEMBERS (RM BANDS A-D)

Subscriptions are based upon total relevant annual sales of raw materials only into the adhesives and sealants sector (see also Group Membership), and fees are calculated on the relevant turnover band. Any change in the basis or membership is subject to the six months' notice requirement. Relevant turnover is assessed via a self-declaration.

ASSOCIATE MEMBERSHIP (AM)

Associate membership is available for members whose business is not directly related to the supply of raw materials or adhesives and sealants.

- **CONSULTANCY MEMBERSHIP (CM)**

Consultants can apply for membership if their business is relevant for the sector and a flat fee of £350 is charged for self-declared turnover under £500,000. Contact the office for fees if the size of the consultancy turnover in the sector is greater than £500,000. Membership is offered subject to the six months' notice requirement.

- **RETAILERS & SERVICES MEMBERS (AM-R&S)**

Flat fee membership is offered subject to the six months' notice requirement.

- **EQUIPMENT SUPPLIERS (AM-ES & SEALANT APPLICATORS (AM-SA)**

Flat fee membership is offered for equipment supplier companies and sealant applicators, with no notice period. Membership automatically expires unless confirmation of intention to renew is received.

- **STUDENT MEMBERSHIP (AM-SM)**

Monthly membership is offered for students, with no notice period. Membership automatically expires when payment ceases.

- **TAPES & ADHESIVE BACKED PRODUCTS MEMBERSHIP (AM-T)**

A special three-year membership offer is available with membership automatically expiring at the end of the 3-year period unless a request to renew is received.

GROUP MEMBERSHIP

Companies may join either on an individual or group company basis. If Group Membership is chosen, total turnover is combined to determine the subscription band. Qualifying companies within the Group may be listed in the BASA Handbook, on the website, in other promotional material, and in circulation lists, but the Group will be entitled to only one vote in any Association ballot.
